Dear Sir Robert Goodwill,

I read your article in the Yorkshire Post on Saturday 27th August.

It seems you support the West Pier development, that it is a done deal and that you believe it is too late for it to be stopped.

It is not .... and please .... have not an inkling of uncertainty this proposed West Pier Development will NOT go ahead.

I am sure you will have read my letters to Council and to the Town Deal Fund Board.

Maybe you did not believe what I was saying or perhaps you support Mr Siddons and Mr Kerfoot with their invidious replies, if so you are indeed politically a very brave man in siding with your opposition, a dubious Labour Council Leader against your own constituents, your own voters and the whole community.

For the avoidance of any doubt, in case you missed my earlier correspondences and in summary hear are just a few of the issues I have previously aired;

THE WHOLE SEAFRONT COMMUNITY....the Fishermen, the Harbour users, the Shop Keepers, the Cafes, The Restaurants, The Bars, the Donkey and the Deckchair concessions, the Amusements, the Fairground, the Boat trip operators, the Pubs, the Take Away businesses, the Crab Stalls, local residents, the large businesses down to the smallest businesses (apart from one single Trader) ALL STAND UNITED AGAINST THIS PROJECT.

5.) The Town Deal Fund Board by rubber stamping the false application for funding have either been complicit or ignorant of what has gone on.

There to provide protection from corruption and dishonesty for the community, they have taken charge of onerous responsibilities both as a board and as individuals to ensure all the stages of the scheme are properly exacted.

Each member of this Town Deal Fund Board has failed completely in their duty and the board as a whole has failed to have any direct communication with the community, the stakeholders and anyone else affected.

They have laid themselves open to legal actions against them and seriously damaged reputations.
