I read that your Appeal EA-2022-0223 against providing some public information was Struck-Out by the Tribunal Judge and you were informed about this last December. But this important failure of Potto Councils policy has not been published so far in 2023. So I want to ask you for information:-

- 1) for the date the Tribunal informed you your Appeal was Struck-Out.
- 2) for a copy of the Clerks email (or similar) informing all Councillors the Appeal had failed.
- 3) for a copy of the email (or similar) the Council sent to the original information requester in order to comply with the now affirmed ICO decision notice.
- 4) for information to explain why this Judgement has not been included or shown on the January, February or March 2023 agenda or minutes.

A final word - I have been looking at quite a few of the Council's responses on this website and I find them often to be evasive and unhelpful and unlawful, which I think explains why this big failing was part of the condemnatory 2022 Public Interest Report. But I see you are claiming this big problem has now all been sorted out, so if it has, I expect to receive helpful and accurate responses to my information request - thanks very much in anticipation.



The Judge also found your claim about vexatious was 'not in accordance with the law'. So any previous claims from 2016/19 are now overturned and annulled orvoid. If the 2022 PIR really had been properly sorted out, your unlawfulnes couldn't have happened again - but the Judge said in June 2023 it did.

So we now know all your comments about whistleblowers vexatious behaviour are unlawful. I also guess libellous is a fair description.

I see another article http://nyenquirer.uk/worst-parish-council/ says audit body SAAA published data that meant PottoCouncil was the worst out of 10,000 others for governance and accountability. I think this data supports my view.
